### **Old Business**

On Saturday, June 17 from 8AM- 12 PM, the Town Rec. Department had to cancel the Trout Pond Clean Up because of inclement weather. Another Pond Clean Up will be rescheduled in September.

- 1. The Surfrider Foundation's Blue Water Task Force representatives will discuss their efforts to protect our beaches and their achievements in water sampling and beach clean ups.
- 2. The Town Trustees will discuss their duties in managing 26,000 acres of underwater lands, lakes and ponds. Reseeding the bays with shellfish, and overseeing the endangered species program is a major accomplishment. The Trustees also run the program to pump out effluent from boats, oversee and manage docks, bulkheads, moorings, launching ramps and the permitting of these structures. The Trustees work with Stony Brook and Cornell on water quality and shellfish management areas with the Town.

### **NOTES ON PESTICIDE SPRAYING**

### Suffolk County "No-Spray" Registry

For people who do not want their property subject to adult mosquito control (aerosol and fog applications). Larval control (application to water that's breeding mosquitoes) is not included. ### The NYS DEC Neighbor Notification Law

The Neighbor Notification Law created these sections requirements:

- providing at least 48-hour prior written notice to neighboring properties, and to occupants of multiple dwellings for the site of a pesticide application, for certain commercial lawn pesticide applications;
- posting of visual notification markers for residential lawn applications and;
- posting of an information sign by retailers who sell general use lawn pesticides.
